

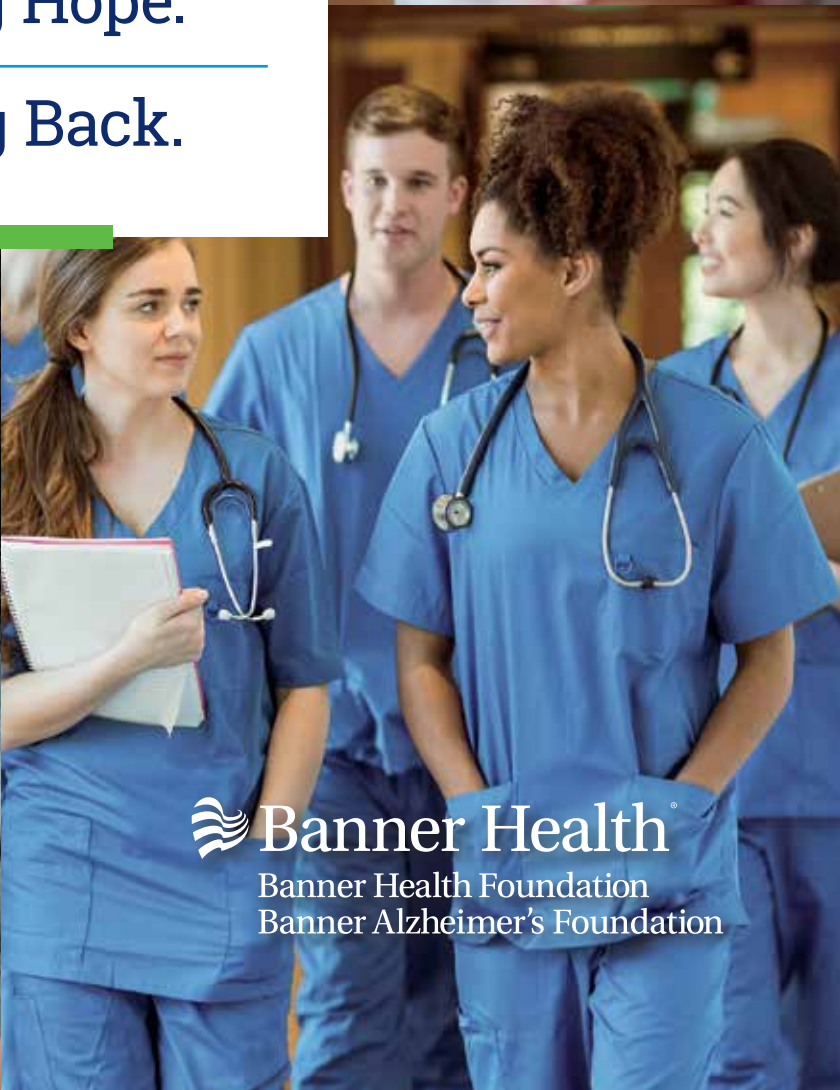

# Banner Health History



On Sept. 1, 1999, two nonprofit health care systems—Samaritan Health System and Lutheran Health Systems—announced their merger, which would form Banner Health. Today, Banner Health is one of the largest nonprofit health care systems in the country and the leading nonprofit provider of hospital services in all the communities we serve in Arizona, California, Colorado, Nebraska, Nevada and Wyoming.

Recognized for the clinical quality consistently provided to patients in our hospitals, nonprofit Banner Health is headquartered in Phoenix and operates 28 acute-care hospitals, Banner Health Network, Banner – University Medicine, academic and employed physician groups, long-term care centers, outpatient surgery centers and an array of other services, including home care and hospice services, pharmacies, and a nursing registry.

Banner Urgent Care facilities and Banner Health Centers are located throughout the communities we serve to make quality care convenient, accessible and affordable, and to serve those who might not otherwise seek medical care until an emergency.

In 2015, Banner underwent historic growth when it completed a merger with the University of Arizona Health Network to form Banner – University Medicine. This new division of Banner Health includes three academic medical centers in Phoenix and Tucson, as well as specialty institutes in heart, stroke, diabetes and endocrine, bariatrics, women's health, neurology, orthopedics, transplant, and rehabilitation.

## Oncology

Options for supporting the work of Banner MD Anderson Cancer Center's main Gilbert campus and expansion sites around the Valley include:

- **Research** conducted through clinical trials, supporting the discovery of new treatments and giving patients access to the latest breakthroughs
- **Patient Assistance Funds** to help qualifying patients with the cost of diagnostic imaging, radiotherapy, a wig purchase, and local lodging
- **Integrative Medicine programs** that offer complementary therapies, evidence-based alternative therapies, wellness programs, nutrition and exercise programs, and more
- **myCancerConnection®**, a program that pairs those undergoing cancer treatment with a compatible and compassionate survivor with the same or similar diagnosis
- **Disease-specific funds and general funds**, supporting the greatest needs at the Cancer Center, now and in the future



## Pediatrics

Options for supporting our three Banner Children's medical centers in Mesa, Glendale and Tucson include:

- **The Hospital School**, helping children keep up with their studies while receiving in-patient care
- **Toy Closets**, offering children the chance to choose and keep a new toy after undergoing procedures and treatments
- **Music Therapy**, provided at the bedside or in small groups by board-certified music therapists
- **Outdoor playgrounds, healing gardens and indoor recreation spaces** for children of all ages, giving young patients the chance to get fresh air, exercise and relax
- **Child Life** specialists are specially-trained professionals working with children of all ages to reduce anxiety, using medical and play therapy to calm fears, and providing emotional support for parents and young siblings
- **Mobile and Community Clinics**, offering free basic health care services, immunizations and prescriptions to uninsured children
- **Banner Academy**, a nationally accredited private school that educates children on the autism spectrum and those with emotional and learning disabilities
- **General funds**, supporting the most important needs at Banner Children's, even as those needs change over time





## Alzheimer's

Options for supporting the work of Banner Alzheimer's Institute include:

- **Research** aimed at preventing Alzheimer's and dementia
- **Diagnosis and clinical care** in the Stead Family Memory Center in Phoenix and Cleo Roberts Memory Center in Sun City, as insurance does not fully cover the extended time the physicians spend with patients and families
- **Family & Community Services**, including education, resources, support groups and one-of-a-kind life enrichment programs for families of those facing Alzheimer's or dementia
- **Native American Community Outreach**, educating the community about Alzheimer's disease and dementia and caregiving strategies in Tribal communities
- **Grief and Loss programs**, including classes, educational resources, and support groups for caregivers dealing with grief, loss and difficult emotions
- **Funding** to expand Banner Alzheimer's Institute's world-class comprehensive care model to Southern Arizona and support for the provision of clinical and family services

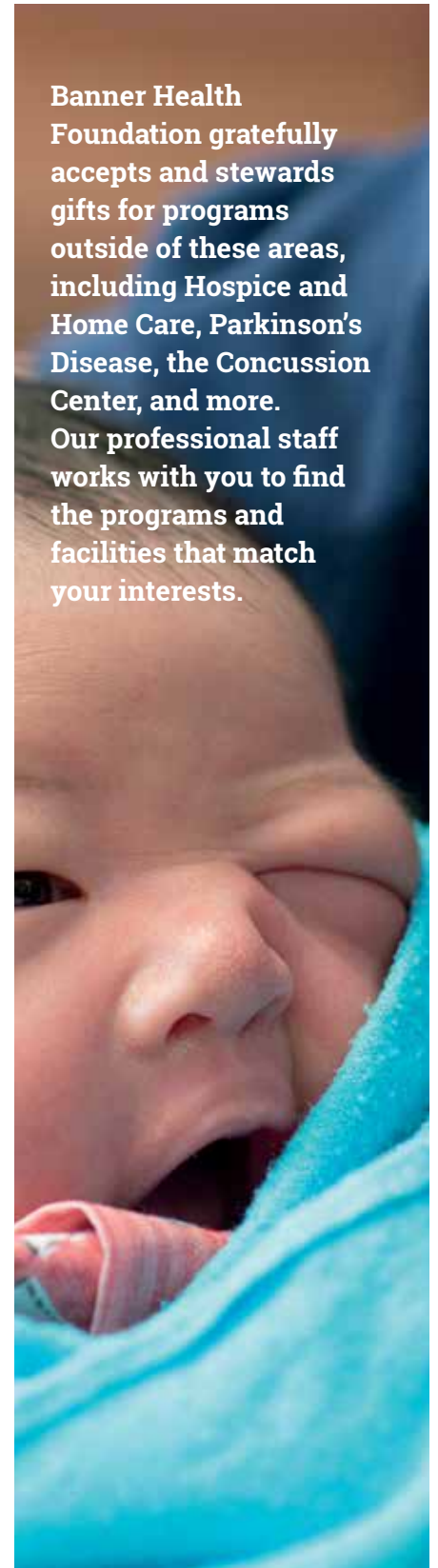


## Cardiovascular Disease within Banner—University Medicine

Options for supporting cardiovascular care in our academic medical enterprise include:

- **Patient care** programs in the areas of structural heart disease, women's cardiovascular health, heart rhythm disorders, advanced heart failure, heart disease prevention, and imaging and heart transplant
- **Endowed Chairs** honor both the donor and the named holder of the appointment and help to attract, reward and retain distinguished faculty of national and international reputation
- **Training and Education** through Cardiology Fellowships provide young physicians broad exposure to diseases, teach appropriate use of diagnostic studies, and require active participation in research projects to give the physician further experience in critical thinking and literature evaluation
- **Research** studies and clinical trials of new heart disease treatments give patients access to the latest investigational medications and therapies today, and advance medical discoveries to benefit future patients

# Ways to Give

## Lifetime Giving

### Common Gift Types:

**Pledges:** Sustain important programs by giving on a recurring basis, with payments made monthly, quarterly or annually. For your convenience, payments may be made through automatic bank withdrawal or by credit card.

**Tribute and Memorial Gifts:** Giving is a thoughtful way to celebrate a special occasion or honor family or friends. Memorial gifts honor the memory of a loved one and support important programs at Banner Health. Both may be designated to the facility, area of care, or program of your choosing.

**Gifts of Gratitude:** Honor a Banner employee who made a difference during your hospital stay with a donation in his or her name. Each honored employee receives a certificate commemorating the honor and a Banner Health Hero lapel pin.

**One-Time Gift:** The simplest way to make a gift is by check or credit card.

### Non-Cash Gifts:

**Stocks, Bonds and Mutual Funds:** Giving appreciated stocks, bonds and mutual funds results in a charitable deduction for the full market value and can minimize capital gains tax.

**Real Property:** A home, ranch, business or land can become a significant charitable gift. Avoid capital gains on the property's appreciation and receive a charitable deduction for its fair market value.

**Vehicles:** Banner Health Foundation and Banner Alzheimer's Foundation gratefully accept donations of motorized vehicles including cars, trucks, boats, and RVs.

## Planned Giving

**Bequest:** Name Banner Health Foundation or Banner Alzheimer's Foundation to receive all or a percentage of your estate in your will or trust.

**Retirement Assets:** Double taxation reduces the value of retirement accounts when passed to heirs or non-charitable beneficiaries. Consider donating all or part of the unused retirement assets in your IRA, 401(k), 403(b), pension or other tax-deferred plan. The Foundation benefits from the full value of your gift and your estate will benefit from a charitable gift deduction.

**Life Insurance:** If you have a life insurance policy that has outlasted its original purpose, consider gifting the policy. Upon your passing, your estate receives a charitable deduction and the death benefit passes to the Foundation tax-free.

**Charitable Gift Annuity:** A contract between you and Banner Health Foundation where, in exchange for your charitable gift, you or a loved one receives income in the form of set payments for life.

**Charitable Trusts:** Various types of trusts offer an ideal way to convert highly appreciated assets into a lifetime income without having to pay capital gains or estate taxes, while also providing a meaningful gift to Banner Health.

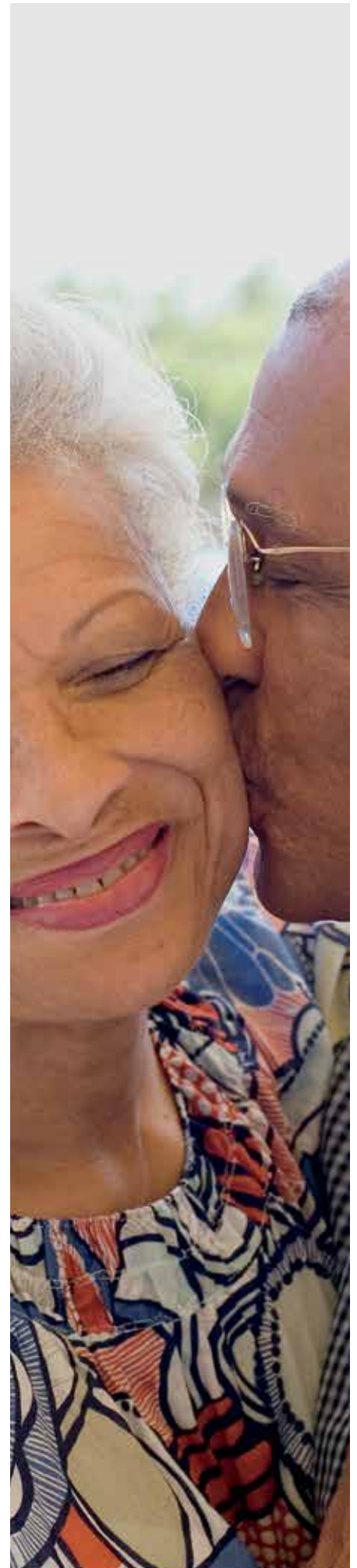
## Legacy Society

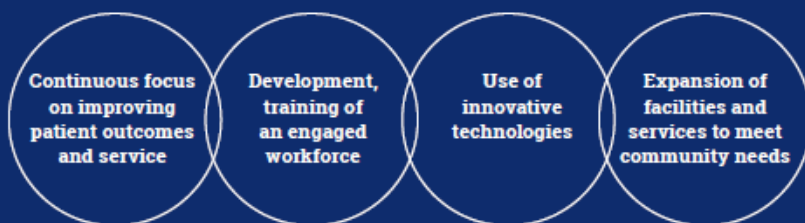
